

# Privacy policy

North Sea Watersports online Bookingform is provided from Viking bookings in Den Haag. North Sea Watersports is responsible for that Viking bookings responsible processes your personal data. We inform you of what personal data we use and for what reason by means of this Privacy Statement.

The present Privacy Statement only applies to the use of the Viking bookingform, as well as to the website of North Sea Watersports and to the Viking bookings servers. The processing of the personal data takes place in accordance with the provisions of the Personal Data Protection Act.

## **Reasons for the processing of personal data**

The reasons why North Sea Watersports process your personal data are twofold. On the one hand it is necessary that your personal data is used in order to make the planning of your booking possible. For example, to schedule you to the right instructor / equipment, on the right day. Possibly with the correct other students based on weight, age, language, previous experience and other comments. On the other hand the processing of your personal data is necessary in the context of:

- the delivery, maintenance, security and improvement of our services;
- the protection of the rights or the ownership of North Sea Watersports and Viking bookings or the users;
- the functioning of the Viking bookingform;
- the development of new services.

Your personal data will be (virtually entirely) processed on the servers of North Sea Watersports and Viking bookings in the Netherlands.

## **Scope and permission:**

By making use of the website from North Sea Watersports and the services related thereto, you expressly agree to the collection, use, publication and storing by North Sea Watersports and Viking bookings of your personal data, as described in this Privacy Statement and the general terms and conditions.

## **Your rights**

North Sea Watersports and Viking bookings do not provide any personal data to third parties. You can at any time request access to the data that we collect about you and to have this corrected or removed. ## **Data protection**

We protect your data with the assistance of technical and administrative safety measures to reduce the risk of loss, misuse, unauthorized access, disclosure, and change as much as possible.
